Sir/ Madam,

In reference to Medical Assessment and Rating Board for Homoeopathy (MARBH) letter No. 4-7/ MARBH/NCH/2025-26(109-02)/1636 dated 14.05.2025 Shree Dr. V.H. Dave Homoeopathic Medical College & Hospital and Smt. S.I. Patel Homoeopathic Hospital, Hahnemann House, Amul Diary Road, Anand, Gujarat has filed an appeal to the commission against the decision of MARBH vide their letter no. HMC/107/2025, dated 10.06.2025.

Commission has recommended MARBH vide letter no. 30-5/2025-26/NCH-GR (17)/3554, dated 14.07.2025 for the continuation of permission for 125 seats(Including EWS) for 1st BHMS course and 09 seats for PG Course in 03 subjects namely Organon of Medicine with Homoeopathic Philosophy with 03 seats, Homoeopathic Materia medica with 03 seats, Homoeopathic Repertory and Case taking with 03 seats to the Shree Dr. V.H. Dave Homoeopathic Medical College & Hospital and Smt. S.I. Patel Homoeopathic Hospital, Hahnemann House, Amul Diary Road, Anand, Gujarat for the academic year 2025-26. Accordingly, MARBH is granting Conditional Permission for 125 seats (Including EWS) for BHMS Course and 09 seats for PG Course in 03 subjects namely Organon of Medicine with Homoeopathic Philosophy with 03 seats, Homoeopathic Materia medica with 03 seats, Homoeopathic Repertory and Case taking with 03 seats for the academic year 2025-26 based on the following conditions that college has to appoint remaining teaching faculty as per NCH regulations.

All admissions shall be made from NEET/ AIAPGET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of 125 seats (Including EWS) for BHMS course and PG course with intake capacity of 09 seats shall be treated as All India Quota. Counselling for seats under All India Quota shall be conducted by the Central Government and counselling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT designated by Central Government. The permission of the college


stands withdrawn if the college fails to comply with the aforesaid direction of the Central Govt. for All India Quota or the student admitted thereunder.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/ AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board.

**Permission to the college can be withdrawn in the subsequent year if college is found deficient in compliance to MES-2024 anytime during the academic year.**
